

## **Privacy Policy Graduate School CuKnow**

This privacy policy contains information about the processing of your personal data when applying for the Graduate School CuKnow of the Karlsruhe Institute of Technology (KIT).

#### I. Personal Data

For the administration of the Graduate School CuKnow, KIT processes personal data. According to Art. 4, No. 1 of the EU General Data Protection Regulation (GDPR), personal data is "any information relating to an identified or identifiable natural person".

#### II. Controller

## IV. Storage duration

We delete all of the aforementioned data in relation to the membership of the Graduate School, if they are no longer required for the purposes for which they were collected and no statutory retention requirements apply.

## V. Recipients

The personal data are processed by the KIT employees responsible for the administration of the Graduate School CuKnow and, if necessary, by supporting organizational units of the administration of KIT. Application materials will be provided to the CuKnow Graduate School Board of Directors, which will decide on admission.

#### VI. Legal basis

The legal basis for the processing of personal data during registration and application is Art. 6, par. 1 (e), par. 3 (b) GDPR in conjunction with section 2 (1),(2) and section 20 KIT-Gesetz in conjunction with section 12 Landeshochschulgesetz (LHG, Higher Education Act of the state Baden-Württemberg).

## VII. Rights

You have the following rights regarding your personal data:

- the right to obtain confirmation as to whether data concerning you is being processed and information on the data processed, further information on data processing, and copies of data (Art. 15 GDPR)
- the right to rectify or complete inaccurate or incomplete data (Art. 16 GDPR)
- the right to erasure of data concerning you without undue delay (Art. 17 GDPR)
- the right to restriction of processing (Art. 18 GDPR)
- the right to object to the future processing of the data concerning you which is based on Art. 6, par. 1, point (e) or (f) GDPR (Art. 21 GDPR)

You also have the right to lodge a complaint with a supervisory authority about the processing of the personal data concerning you by Karlsruhe Institute of Technology (KIT) (Art. 77 GDPR). Supervisory authority of KIT in the sense of Art. 51, par. 1 GDPR is according to Art. 25, par. 1 LDSG:
